

FORD CITY BOROUGH ORDINANCE NO. 15

Ordinance Grant, g to the Kittanning Telephone Company, a Corporation under the laws of Pa. the right to erect poles and wires upon the Streets, Lanes and Alleys of the Boro. of Ford City, Armstrong Co. Pa.

Section #1. Be it enacted and ordained by the Burgess and Town Council of the Boro. of Ford City and it is hereby ordained and enacted by the authority of the same, that the privilege is hereby granted to the Kittanning Telephone Co. aforesaid to erect such poles in and upon the Several Streets, lanes and alleys and to string such wires thereon as may be necessary for the purpose of erecting and maintaining lines of Telephone through said Boro. and also to the places of business, works, manufacturers, offices and houses of subscribers, within said Boro. limits for telephone purposes upon the acceptance in writing of this ordinance by the said Kitt'ng Telephone Co. within 10 days from the date of the passage of this ordinance,

Section #2. The poles to be erected shall be of neat design and shall be erected under the supervision and control of the said Town Council, or its proper Committee and to be erected at such points as Council or said Committee may direct. The location of any of said poles shall be changed by said Company when public convenience may require it on thirty days written notice given by said Council or said Committee, provided that such change shall not interfere with the practicability of maintaining said line.

Section #3. That the said telephone Co. shall leave all the St. lanes and alleys, pavements, Sewers and Curbs in as good condition as they find them. If the said Telephone Co. shall neglect to do so the Boro. authorities may after 5 days written notice make such repairs and collect the cost thereof from said Co.

Section #4. That the said Telephone Co. in consideration of said franchise agrees to furnish to said Boro. Two telephones and service for same to be placed where directed by said Council and kept in repair by said Co. The Telephone and service for said Boro, shall be furnished free of cost. Immediately upon commencing business the said Co. through its president shall make and file with the Boro. Treas. a sworn statement of the number of poles erected and the no. of miles then in use by said Co., and annually thereafter on the 1st day of January of each year make and file such statement for each and every year and immediately pay to the Treas. of said Boro. the proper and correct amount of the Pole and Wire Tax on said poles and wire as regulated by the General Ordinance of said Boro.

Section #5. All ordinances or parts of ordinances inconsistent with the provisions of this ordinance are hereby repealed.
