

FORD CITY BOROUGH ORDINANCE NO. 38

An Ordinance vacating 284 feet of the Southern end of that certain alley running North and South, Midway between Fourth and Fifth Avenues between Eleventh and Twelfth Streets, and also vacating that certain alley at right angles with Fifth Avenue running westerly from the northeastern corner of lot No. 754 in the Borough of Ford City, Armstrong County, Pa.

Be it enacted and ordained by the Burgess and Town Council of the Borough of Ford City, and it is hereby enacted and ordained by the authority of the same.

First. That that portion of a certain alley designated in the General plan of said Boro. duly recorded in the recorders office of Armstrong County in Deed Book Vol. 90, pages 16 to 20 inclusive and by Ordinance of the said Borough dated Oct. 6, 1899, bounded and described as follows: Beginning at Eleventh Street at southwest corner of lot No. 740 in said plan, thence by the eastern line of lots Nos. 740, 755, 757, 759, 761, 763, 765 and part of lot No. 767, a distance of 284 feet to point on line of proposed alley; thence at right angles of said line of proposed alley sixteen feet to a point on western line of lot No. 1154; thence at right angles with said line by the western line of lots Nos. 1154, 1152, 1150, 1148, 1146, 1144 and 1142, one hundred and fifty-nine feet to an alley; thence directly across said alley 13 feet wide, to the northwest corner of lot No. 742; thence by the western line of lot No. 742 one hundred and twelve feet to eleventh street, thence by the northern line of eleventh street sixteen feet to the place of beginning, being sixteen feet wide by 284 feet long.

And also that certain other alley so designated on the said plan of lots and bounded and described as follows: Beginning at the southeast corner of lot No. 1142 in said plan, at the corner of Fifth Avenue and an alley, thence by the southern line of said lot and alley 140 feet to a 16 feet wide alley; thence by said 16 feet wide alley, 13 feet to the northwest corner of lot No. 742, thence by the line of said lot and northern line of lots Nos. 744, 746, 748, 750, 752, 754 and said alley, 140 feet to line of Fifth Ave. and thence by the western line of Fifth Avenue northerly 13 feet to the place of beginning, being 13 feet wide and 140 feet long, be and the same are hereby vacated.

Second. All Ordinances and parts of ordinances inconsistent with the provisions of this ordinance, and particularly the Ordinance of Oct. 6, 1899 as printed in present Ordinance Book on page 46, are hereby repealed in so far as the same affect this ordinance.
