

**MINUTES  
FORD CITY BOROUGH COUNCIL  
SPECIAL MEETING

JUNE 28, 2004**

**CALL TO ORDER** Council President Kozuch called the meeting to order at 5:15 p.m. and advised everyone the meeting is being audio taped.

**ROLL CALL** Terry Tokarek, Homer Pendleton, Steve Kozuch, John Rudosky, and Dan Cousins. Tim Malec was absent because of work.

**ATTENDANCE** Mayor Pyle, Fred Dzugan - Codes Officer, Donna Kornasiewicz - G.F.C.C.D.C., and Solicitor Frank Wolfe.

**MEETING ADVERTISEMENT**  
Councilman Cousins asked if this meeting was advertised? The Secretary answered yes it was.

**UNIFORM CONSTRUCTION CODE**  
Councilman Rudosky explained the Borough must opt in or opt out and the Commonwealth still has questions regarding this ordinance.  
  
Rudosky made a motion to adopt the Uniform Construction Code Ordinance as presented and prepared by the Commonwealth of Pennsylvania and adopt as required by law. Seconded by Cousins. Motion Carried. 5-0 Unanimous

**PROPERTY MAINTENANCE CODE**  
Dzugan explained he made copies of the Property Maintenance Code for all councilmen. Dzugan explained this code deals with existing structures only and cleans up any antiquated ordinances.  
  
A discussion took place concerning the changing Uniform Construction Code and the Property Maintenance Code.  
  
Solicitor Wolfe stated the way the Ordinance was written and the Ordinance that was passed is the Uniform Construction Code as the State Legislature amends it. Any amendments that the State Legislature makes to the Ordinance are automatically included in this Ordinance.

Rudosky stated he would like more time to review the Property Maintenance Code.

Dzugan explained there are forms residents must complete regarding any

work done under the rules of the Property Maintenance Code. Dzugan stated he will develop the forms Ford City Borough must use and have Solicitor Wolfe review them before delivering the final form to council.

Dzugan explained a new set of 2003 IRC/IBC International Residential Code /International Building Code books must be ordered for the office and the cost is around \$400.00.

Pendleton made a motion to authorize the Secretary to order the books. Seconded by Rudosky. Motion Carried. 5-0 Unanimous

Dzugan explained the letter from Rep. Coleman dated 6-25-2004. It explains the responsibilities of the communities that opt in and adopt the Uniform Construction Code or chose to opt out and not adopt the Uniform Construction Code.

#### BOARD OF APPEALS

Dzugan explained that since the Borough adopted the Uniform Construction Code Ordinance they must now create a Board of Appeals. Solicitor Wolfe explained that a Board of Appeals should have been adopted a number of years ago.

A discussion took place concerning the requirements of the Appeals Board.

Council President Kozuch directed the Secretary to contact Donna Rupert and ask who is on their board and are they compensated.

Dzugan stated if a citizen has a problem there must be a mechanism in place to resolve the issue. The Board of Appeals will protect the Borough and the builder.

Cousins made a motion to advertise for qualified persons interested in serving on an Appeals Board for the Uniform Construction Code to submit a resume to be reviewed by the Borough Solicitor and qualifications recommended by Fred Dzugan - Codes Officer. Seconded by Rudosky. Motion Carried. 5-0 Unanimous

Cousins explained the Appeals Board may never be called upon, but is necessary.
