A RESOLUTION OF THE BOROUGH OF FORD CITY,
ARMSTRONG COUNTY, PENNSYLVANIA, ADOPTING AN
AMENDMENT TO THE ARTICLES OF INCORPORATION OF
FORD CITY BOROUGH MUNICIPAL SEWAGE DISPOSAL
AUTHORITY.

WHEREAS, Ford City Borough Municipal Sewage Disposal Authority has submitted to the Borough Council of the Borough of Ford City a resolution amending the Articles of Incorporation of Ford City Borough Municipal Sewage Disposal Authority.

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of Ford City, and it is hereby resolved by authority of the same as follows:

Section 1. The Borough of Ford City hereby adopts the following amendment to the Articles of Incorporation of Ford City Borough Municipal Sewage Disposal Authority, which amendment shall consist of the following new provision to be added to the said Articles of Incorporation:

"(6) The term of existence of the Authority is increased to a date fifty (50) years from the date of approval of these Articles of Amendment."

Section 2. All resolutions or parts of resolutions not in accord with this Resolution are hereby rescinded insofar as they conflict herewith.
