BOROUGH OF FORD CITY

AN ORDINANCE AMENDING ALL ORDINANCES LISTED TO INCREASE THE FINES AND PENALTIES OF THE VIOLATION OF EACH ORDINANCE TO AN AMOUNT NOT TO EXCEED \$600.00 OR \$1,000.00 AS PERMITTED BY ACT NO. 1988-18 OF THE PA. GENERAL ASSEMBLY APPROVED MARCH 2, 1988 AMENDING SECTION 3308 OF THE BOROUGH CODE - COLLECTION OF PENALTIES.

THE COUNCIL OF THE BOROUGH OF FORD CITY HEREBY ORDAINS AS FOLLOWS:
