SUPPLEMENTING AND AMENDING ORDINANCE NOS.
448, 518, 552, 574, AND 586; AMENDING AND
SUPPLEMENTING WATER RATES.

BE IT ORDAINED AND ENACTED BY THE TOWN COUNCIL OF THE BOROUGH
OF FORD CITY, AND IT IS HEREBY ORDAINED AND ENACTED BY AUTHORITY
OF THE SAME:

SECTION I:

Section II of Ordinance No. 458, Section I (a) and
Section I (b) of Ordinance No. 518, Section I of Ordinance No. 552,
Section I of Ordinance No. 574, and Section I of Ordinance No. 586
of the Borough of Ford City are hereby amended to read as follows:

IMPOSITION OF WATER RATES

Effective for the billing period from November 20, 1990
through December 20, 1990 mailed December 31, 1990 and
due at face January 15, 1991, the following schedule of
rates for the consumption of water is hereby imposed. The
following rates shall apply to each specific metered service
connection to the main water distribution system regardless
of whether two or more service connections provide water to
an individual customer.
