

AN ORDINANCE PROVIDING FOR THE
COMPREHENSIVE REGULATION OF
DOWNTOWN THIRD AVENUE PARKING
IN THE BOROUGH OF FORD CITY

THE COUNCIL OF THE BOROUGH OF FORD CITY HEREBY ORDAINS AS FOLLOWS:

SECTION 1:

a. ESTABLISHMENT OF PERMIT PARKING ZONE: A permit parking zone is hereby established on the West Side of Third Avenue from Ninth Street to Eleventh Street and on the East side of Third Avenue from Tenth Street to O'Connor Street from Monday through Friday between the hours of 8:00 o'clock a.m. and 5:00 o'clock p.m.

b. ESTABLISHMENT OF PERMIT PARKING SUB-ZONES: The above defined Parking Zone shall be further divided into sub-zones. The said sub-zones are established as follows:

Sub-zone 1: The West Side of Third Avenue from Ninth Street to the Clock Tower;

Sub-zone 2: The West Side of Third Avenue from the Clock Tower to Tenth Street;

Sub-Zone 3: Both the West and East Sides of Third Avenue from Tenth Street to O'Connor Street; and

Sub-Zone 4: The West Side of Third Avenue from O'Connor Street to Eleventh Street.

c. FEES: Any licensed driver, on a first come first serve basis, may purchase a monthly parking permit for a vehicle at a prepaid rate of:

Sub-Zone 1: \$20.00 per month

Sub-Zone 2: \$20.00 per month

Sub-Zone 3: \$15.00 per month

Sub-Zone 4: \$10.00 per month

The above fees are initial fees and may be changed from time to time by Resolution of the Council of Ford City Borough.

Parking permits for Sub-Zone 1 shall be issued only for trucks. Effective June 1, 2002, parking permit Sub-Zone 1 shall be eliminated and it shall become a no parking zone. Enforcement of said no parking zone shall be as provided for by the Traffic Code of the Borough of Ford City.

A permitted vehicle shall be parked in a non-metered parking space unless no such space exists in the Sub-Zone for which the vehicle is permitted, in which case, the vehicle shall not be ticketed for an overtime parking violation during the hours and days of the week specified above for permitted parking.

d. SIGNAGE AND LABELS: Appropriate signage and vehicle labels shall be prepared and installed, as applicable, to accomplish the purposes of this Ordinance.

e. FINES AND PENALTIES: Anyone who violates any provision of Section 1 of this Ordinance, except as provided above, shall be guilty of a summary offense and fined not more than \$300.00 per day and costs of prosecution. In default of the payment of such fines and costs, the violator shall be imprisoned

for not more than 30 days.

SECTION 2:

TWO HOUR PARKING ZONE: No person shall park any vehicle for a period of time longer than two (2) hours on the East Side of Third Avenue between O'Connor Street and Eleventh Street. Enforcement of this Section shall be provided for by the Traffic Code of the Borough of Ford City.

SECTION 3:

REPEALER: Any Ordinance inconsistent herewith is hereby repealed to the extent of any such inconsistency.

SECTION 4:

EFFECTIVE DATE: This Ordinance shall be effective immediately upon passage.
