

TAX LEVY ORDINANCE  
ORDINANCE NO. 655

AN ORDINANCE OF THE BOROUGH OF FORD CITY, COUNTY OF ARMSTRONG, COMMONWEALTH OF PENNSYLVANIA, FIXING THE TAX RATE FOR THE YEAR 2004.

Be it ordained and enacted, and it is hereby ordained and enacted by the Borough Council of the Borough of Ford City, County of Armstrong, Commonwealth of Pennsylvania:

That a tax be and the same is hereby levied on all real property within the Borough subject to taxation for the fiscal year 2004 as follows:

Tax rate for general purposes, the sum of..... 8.25 Mills  
on each dollar of assessed valuation, or the sum of ..... 82.50 cents  
on each one hundred dollars of assessed valuation

Tax rate for Borough Indebtedness, the sum of .....1.00 Mills  
on each dollar of assessed valuation, or the sum of .....10.00 cents  
on each one hundred dollars of assessed valuation

For purposes of funding non uniform employees  
pension retirement, the sum of ..... .15 Mills  
on each dollar of assessed valuation, or the sum of ..... 1.50 cents  
on each one hundred dollars of assessed valuation

For street light purposes, the sum of .....1.65 Mills  
on each dollar of assessed valuation, or the sum of ..... 16.50 cents  
on each one hundred dollars of assessed valuation


For fire apparatus purposes, the sum of ..... 1.30 Mills.  
on each dollar of assessed valuation, or the sum of ..... 13.00 cents  
on each one hundred dollars of assessed valuation

The same being summarized in tabular form as follows:

	Mills on each Dollar of Assessed Valuation	Cents on each One hundred Dollars of Assessed Valuation
Tax Rate for General Purposes	8.25 Mills	82.5 cents
Tax Rate for Borough Indebtedness	1.00 Mills	10.0 cents
Tax Rate for funding Non Uniform Employees Pension Retirement	.15 Mills	1.50 cents
Tax Rate for Street Lighting	1.65 Mills	16.50 cents
Tax Rate for Fire Apparatus	<u>1.30 Mills</u>	<u>13.00 cents</u>
TOTAL	<b>12.35 Mills</b>	<b>123.50 cents</b>




