

ORDINANCE NO. 670

AN ORDINANCE PROVIDING FOR: THE
COMPREHENSIVE REGULATION OF
DOWNTOWN THIRD AVENUE PARKING
IN THE BOROUGH OF FORD CITY,
NO PARKING ZONES, AND THE REPEAL
OF ORDINANCE NO. 644

THE COUNCIL OF THE BOROUGH OF FORD CITY HEREBY ORDAINS AS FOLLOWS:

SECTION 1:

a. ESTABLISHMENT OF PERMIT PARKING ZONE: A permit parking zone is hereby established for both the West and East sides of Third Avenue starting at the first alley North of Ford Street and ending at Eleventh Street, Monday through Friday, between the hours 8:00 o'clock a.m. and 5:00 o'clock p.m.

b. ESTABLISHMENT OF PERMIT PARKING SUB-ZONES: The above defined Parking Zone shall be further divided into sub-zones. The said sub-zones are established as follows:

Sub-Zone 1: Both the West and East sides of Third Avenue from the first alley North of Ford Street to Tenth Street;

Sub-Zone 2: Both the West and East sides of Third Avenue from Tenth Street to O'Connor Street; and

Sub-Zone 3: The West side of Third Avenue from O'Connor Street to Eleventh Street.

c. FEES: Any licensed driver, on a first come serve basis, may purchase a monthly parking permit for a vehicle at a prepaid rate of:

Sub-Zone 1: \$20.00 per month

Sub-Zone 2: \$15.00 per month

Sub-Zone 3: \$10.00 per month

The above fees are initial fees and may be changed from time to time by Resolution of the Council of Ford City Borough. During the days of the week and during the times provided for in 'a.', above, only persons who have a valid parking permit for a Sub-Zone shall be permitted to park a vehicle in that sub-Zone, and then, only in their designated space.

d. SIGNAGE, STENCILING, AND LABELS: Appropriate signage, stenciling, and vehicle labels shall be prepared and installed, as applicable, to accomplish the purposes of this Ordinance.

e. FINES AND PENALTIES: Any person who violates any provision of Section 1 of this Ordinance shall be guilty of a summary offense and shall be subject to be fined in an amount not to exceed \$300.00 per day and costs of prosecution. In default of the payment of such fines and costs, the violator shall be imprisoned for not more than 30 days.

SECTION 2:

NO PARKING ZONES:

a. No person shall park any vehicle along the West side of Third Avenue from Ninth Street to the beginning of Sub-Zone 1.

b. No person shall park any vehicle along the East side of Third Avenue between O'Connor Street and Eleventh Street, between the hours of 8:00 o'clock a.m. and 5:00 o'clock p.m.

c. Enforcement of this Section shall be as provided for by the Traffic Code of the Borough of Ford City.

SECTION 3:

REPEALER: Any Ordinance inconsistent herewith is hereby repealed to the extent of any such inconsistency.

SECTION 4:

EFFECTIVE DATE: This Ordinance shall be effective immediately upon passage.
