

TAX LEVY ORDINANCE
ORDINANCE NO. 682

AN ORDINANCE OF THE BOROUGH OF FORD CITY, COUNTY OF ARMSTRONG,
COMMONWEALTH OF PENNSYLVANIA, FIXING THE TAX RATE FOR THE YEAR 2009.

Be it ordained and enacted, and it is hereby ordained and enacted by the Borough Council of the Borough of Ford City, County of Armstrong, Commonwealth of Pennsylvania:

That a tax be and the same is hereby levied on all real property within the Borough subject to taxation for the fiscal year 2009 as follows:

Tax rate for general purposes, the sum of..... 8.25 Mills
on each dollar of assessed valuation, or the sum of 82.50 cents
on each one hundred dollars of assessed valuation

Tax rate for Borough Indebtedness, the sum of1.00 Mills
on each dollar of assessed valuation, or the sum of10.00 cents
on each one hundred dollars of assessed valuation

For purposes of funding non uniform employees
pension retirement, the sum of15 Mills
on each dollar of assessed valuation, or the sum of 1.50 cents
on each one hundred dollars of assessed valuation

For street light purposes, the sum of1.65 Mills
on each dollar of assessed valuation, or the sum of 16.50 cents
on each one hundred dollars of assessed valuation

For fire apparatus purposes, the sum of 1.30 Mills.
on each dollar of assessed valuation, or the sum of 13.00 cents
on each one hundred dollars of assessed valuation

For public library purposes, the sum of1.00 Mills
on each dollar of assessed valuation, or the sum of 10.00 cents
on each one hundred dollars of assessed valuation




Tax Rate for funding Non Uniform Employees Pension Retirement	.15 Mills	1.50 cents
Tax Rate for Street Lighting	1.65 Mills	16.50 cents
Tax Rate for Fire Apparatus	1.30 Mills	13.00 cents
Tax Rate for Public Library	1.00 Mills	10.00 cents
TOTAL	13.35 Mills	133.50 cents
