Harmon made a motion to hire Clarissa Garay, Elizabeth Shiring, Aaron Shriver, Allyson Suwala, Erin Suwala, and Nikki Wolfe for the 2010 playground supervisors positions for hours not to exceed 20 hours/week from 10 a.m. until 2 p.m. obtaining Act 34 Clearance and to be paid the rate of PA State Minimum Wage and to be scheduled as needed.
